Creative License: Dave Henrys shall be granted creative and artistic license in relation to the photographs taken, the choice of locations and poses used. Dave's judgement on photographic style and the number of photographs taken shall be deemed correct. Subject to changes in the weather and the availability and willingness of subjects, Dave will do his best to honour any requested photographs, but does not undertake to guarantee any specific picture, background, location or group arrangement.

Viewing: Before the wedding, a mutually convenient appointment will be made for the viewing of photographs upon return from honeymoon.

Copyright: The 1998 Copyright, Designs and Patents Act assigns copyright to Dave Henrys. It is illegal to copy or allow to be copied any photograph covered by this contract, unless it is specified in this contract that high resolution images are to be provided on disk or USB (in which case absolute licence is given for the reprint and distribution of those images).

Display: Dave Henrys reserves the right to use any photograph for display, exhibition, competition, advertising, publicity or editorial purpose.

Exclusivity: Dave Henrys shall be the sole professional (still) photographer at the venue specified. However, family, friends and other guests are actively encouraged to take photographs throughout the day.

Wedding Album: Where an album is selected as part of the collection purchased, images must be selected by the client within six months of the wedding. After this date, Dave Henrys will select suitable images and supply the first proof of the completed album. Any changes then required by the client will be chargeable at £30 per hour and an additional album charge may also be levied if wholesale prices have since increased.

Force Majeure / Act of God: In the unlikely event of total photographic failure, injury or sickness beyond Dave Henrys' control, his liability shall be limited to a full refund of all monies paid. The client's statutory rights are not affected.

Cancellation: If Dave Henrys has to cancel this contract due to reasons beyond his control (death, injury, sickness etc.), his liability shall be limited to a full refund of all monies paid. The client may cancel this contract at any time. After a period of 14 days, their liability shall be limited to the booking fee paid.

Complaints Procedure: Please address all complaints to Dave Henrys either by e-mail or by telephone. All efforts will be made to respond to any complaint within 2 days.

Privacy: Dave Henrys will store your name and wedding details on a private internal database. These details will not be made available to companies or individuals outside of the photographer's business. Should you wish to have your details removed from the database, please advise Dave in writing.
